Strategy Investment Objective

The Fund seeks growth of capital. The Fund will invest at least 80% of its assets in mutual funds and exchange traded funds that are passively managed and seek to track a specific index, consisting of either or both U.S. and foreign equity securities of any capitalization, in order to obtain exposure to the broad global equity market. The Fund, in the aggregate, does not seek to track any particular index. The Fund operates as a fund of funds.

Equity investments will include U.S. equity securities, foreign equity securities, and emerging market equity securities. The Fund's target allocation will be 50% to 70% in U.S. equity indexes and 30% to 50% in international equity indexes. To achieve the Fund's objective, the Adviser intends to utilize a strategic asset allocation approach, which focuses on long-term growth based on long-term returns, risk, and correlation forecasts.

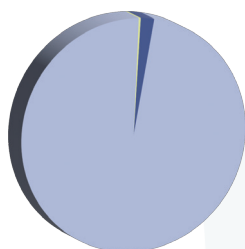

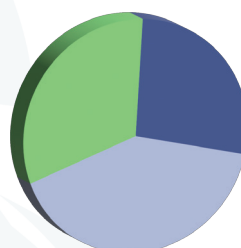

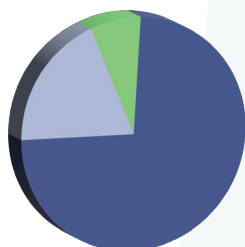

Equity Style



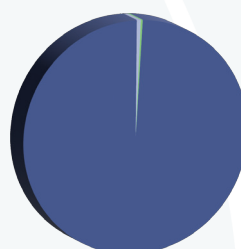

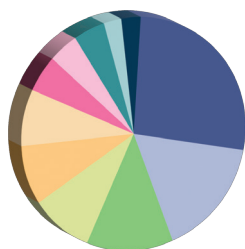

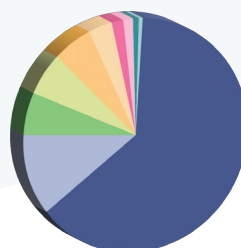

STM: The Fund is a "Fund of Funds" meaning the Fund will invest in other mutual funds and exchange-traded funds (each an "Underlying Fund"). PFG serves as the adviser to the Fund, while Capital Research and Management Company serves as the "Strategist," providing PFG with research services, including data and analysis about the Underlying Funds managed by the Strategist. The Underlying Funds comprise a Model Portfolio managed by the Strategist, so that each Fund is a single ticker model ("Single Ticker Model" or "STM"). PFG has the final responsibility for determining the Underlying Funds purchased and sold by the Fund. PFG and the Strategist are not affiliated.

Fees: PFG receives an annual investment advisory fee from each PFG Single Ticker Model in the amount of up to 1.25%, and The Pacific Financial Group, Inc. ("TPFG"), an affiliate of PFG, receives an annual administrative services fee from each PFG Single Ticker Model in the amount of 0.70%. The Fund does not pay any fees for fund distribution and marketing (Rule 12b-1 fees). In addition, each Fund incurs the costs of the Underlying Funds, known as Acquired Fund Fees and Expenses ("AFFE"). The Fund's gross expense ratio, which includes AFFE, is 1.99%. These fees are indirectly paid by investors, who are shareholders of the Fund.

GLOSSARY OF TERMS

Standard Deviation: Measures how widely a portfolio's returns vary over a certain period of time. A high standard deviation suggests greater volatility.

Beta: Measures the portfolio's sensitivity to markets movements. A beta of 1.00 indicates the portfolio captures 100% of the market's up and down moves. The beta provided is the portfolio beta relative to the stated index.

Sharpe Ratio: Illustrates reward per unit of risk. The higher the Sharpe Ratio, the better the portfolio's risk-adjusted performance.

Sortino Ratio: Measures risk-adjusted return of a portfolio. It is a modification of Sharpe ratio with a specified target rate of return but penalizes any deviation below the target rate of return.

R-Squared: R-squared helps investors understand how much of a portfolio's movement can be explained by the benchmark's performance. For example, an R-squared of 90 means 90% of the portfolio's returns can be attributed to the benchmark's movements, while the remaining 10% is due to other factors (e.g., portfolio manager decisions).

P/E Ratio: The price-to-earnings (P/E) ratio is a financial metric that measures a company's current share price relative to its earnings per share (EPS). It is calculated by dividing the market price per share by the EPS, indicating how much investors are willing to pay per dollar of earnings. A higher P/E may suggest growth expectations, while a lower one could indicate undervaluation.

SEC 30-Day Yield: The 30-Day Yield represents net investment income earned by the Fund over a 30-day period, expressed as an annual percentage rate based on the Fund's share price at the end of the 30-day period.

12 Mo Yield: An expression of the amount paid out in distributions (pre-tax) by the Fund in the last 12 months expressed as a percentage of the previous month end price. Distributions include capital gains, dividend, and interest payments but do not include any return of capital payments.

Avg Market Cap: Market capitalization is the total value of a company's outstanding shares, calculated as share price multiplied by the number of shares. Average market capitalization refers to the weighted average of the market capitalizations of stocks in a portfolio. The average is typically computed by adjusting for each stock's weight in the portfolio, providing insight into the overall size of the companies involved.

Portfolio Management Styles

- **Active:** Manager makes discretionary investment decisions aiming to outperform a benchmark.
- **Passive:** Strategy that tracks an index or market segment with minimal changes or discretion.
- **Strategic:** Establishes a long-term target allocation that bases decisions on fundamentals, long-range forecasts, and investor objectives. Makes portfolio changes infrequently and focuses on consistency and adherence to a long-term plan.
- **Tactical Constrained:** A rules-based approach allowing limited, temporary adjustments to a strategic or passive allocation. It is included with Active and Passive because it sits between them—more flexible than Passive but more restricted than Active.
- **Tactical Unconstrained:** A fast-acting approach solving problems as they arise. Adjusts portfolio plans by prioritizing speed and effectiveness over strict adherence to structure.
- **Diversifier:** A management style that structures a portfolio so that different components behave differently under various market conditions, reducing the impact of any single risk.
